IMPORTANT DATES:

July 24	Firm team commitments are due with \$225 entry fee per team . Coaches listing sheets are due.
Aug. 24 or before	Gym availability/lockout dates are due. If mailed, they <u>must</u> be postmarked by July 22nd Schedules available.
Sept. 1 (Aug 27 for 8th grade)	Complete team rosters are due.
Sept. 12-13 (Aug. 29-30 for 8th grade)	The starting date for the volleyball season.
October 31-Nov 1	Last possible scheduled weekend.

LEAGUE FEES AND COACHES LIST

League fee is **\$225 PER TEAM**, payable to **PARKVIEW PAROCHIAL LEAGUE**.

ROSTERS

Complete rosters signed by the Pastor and/or Principal, Coach, and/or Athletic Director, and if applicable, the CCD Director are required. These rosters must include first and last names of the players, their birth date, and their address and school they attend.

Any waivers for the season must be included with the rosters.

SCHEDULES

Schedules will be drawn up during August. Each school must inform the league in writing by the July 24th commitment date of any event which would cause schedule problems or conflicts, such as scouting camps, concerts, school plays, forensic meets, etc. The league will make every attempt to work with the schools in drawing up the schedule. There are no weekends off due to back-to-back scheduling requirements. **Everyone receiving a schedule is asked to check it over very carefully.** This includes all host gym personnel. Not all teams play at the same time or day each weekend. Some teams may not be scheduled to play at all on a particular weekend, but very unlikely. Each team will play a total of 12 matches during the season. Games can not be scheduled before noon on Sundays.

Please inform Parkview Volleyball of any discrepancies or conflicts as soon as possible.

CANCELLATIONS

The weather advisories posted by the Milwaukee County Sheriff's Department will be strictly followed in the event of severe weather conditions. Coaches and host gyms will be notified by the Parkview Executive Board as early as possible in the case of cancellations. If a day's schedule is canceled for any reason, the executive board will determine the make-up date.

COACHES

Lineups must be turned in to the scorer's table at the beginning of the warm-up period prior to the start of the match. Coaches must indicate the starting line-up at this time with player numbers listed in their starting serving order. Coaches must check for and have all players remove all jewelry, earrings, metal hair clips, etc. prior to the start of warmups. Coaches must also supervise players at all times whether in the immediate area outside the gym, inside the gym watching another game, or in the locker rooms prior to during, and after the scheduled game. Players may not be left unattended.
